This agreement is made this _____ day of _____, 20____, by and between Cisco Fishing Systems, Ltd. hereinafter called "CFS" and the dealer _____ whose address is _____ and hereinafter called the "dealer."

The main components of this agreement are as follows:

CFS will sell to the dealer its products at a predetermined discount. CFS expects that these products will be resold.

The dealer commits to representing CFS in an ethical, active, and professional manner.

The dealer must have a physical place of business.

The dealer is expected to pay by credit card before shipments prior to credit approval.

After credit approval product purchase must be paid within 30 days. Payments over 30 days are subject to 1.5% finance charge on the remaining account balance (18% annually).

The dealer must have a signed sales tax exempt form on file at CFS before any business is transacted.

The dealer agrees to pay all shipping and handling fees on all orders.

CFS does not provide or commit to any consigned products.

CFS does not provide or commit to installment payments on products purchased.

Either party shall have the right to terminate this agreement after the initial period of six months with thirty days written notice.

The dealer must complete both the Dealer Application and this Dealer Agreement.
